At St George's, University of London, we are committed to protecting and respecting your privacy. When you supply any personal information to St George's, University of London we have legal obligations towards you in the way we deal with that data. We must collect the information fairly, explain how we will use it and tell you if we want to pass the information on to anyone else. This notice sets out how any personal data you provide us will be processed.

# Who we are

St George's, University of London is a higher education institute located in Tooting, South London, and is a member of the University of London. We are the 'Data Controller' of the personal data that you provide us with, and we are registered with the Information Commissioner's Office (ICO) for the purposes of UK data protection legislation, registration number Z5770328.

## What information we collect from you and why

We collect your personal data when you apply to be a student ambassador.

The data we collect includes details you provide to us, such as your name, your email, phone number, course and your addresses. We will also collect personal data aligned with our aims to widen access, which will include details about your background, such as your socio-economic history e.g., eligibility for financial bursaries from the government. We use this data:

• For selection for student ambassador jobs

- To provide you with any additional information which is relevant to the job you're being selected for
- To provide you with updates about new activities and job opportunities
- To ensure our student ambassadors reflect the diversity of our student population and those they'll be engaging with when working as an ambassador

If you are an international student on a Tier 4 visa, we also monitor the number of hours you work to ensure the conditions of the visa are not being breached. A monthly report detailing hours worked is sent to the Senior Compliance Officer at St George's, University of London.

Under the Law, we must have a valid legal basis to process your data. In most instances, we will process your data because we have consent from with you e.g. by applying to the scheme you have volunteered that information. We will also use your personal data to send you relevant communications with information and activities that we believe may be of interest to you where we have a legitimate interest in communicating with you. You can unsubscribe to these communications from us at any time.

# Where we store your information and who we share your information with

Your personal data will be processed by St George's University of London as the data controllers. We keep your information securely stored where access is restricted to authorised staff only.

We may also occasionally retain the services of external suppliers to help meet our business needs and may share your data with these suppliers. These suppliers have been selected after a rigorous evaluation process and chosen for their security, reliability and competence. They will process your data only under our instructions. Some of these suppliers may be based in non-EU countries. Where this is the case, the transfer of your personal data to these countries is carried out in compliance with the guarantees provided by law.

Currently the external suppliers we use are:

Your data will never be shared with anyone outside of St George's University of London or Its approved suppliers, without first obtaining your consent, unless we are obliged or permitted by law to disclose it.

## How long we keep your information for

We keep your personal data for a limited period of time in line with our data retention schedule. The specific retention period will vary according to the reason for processing your personal data. After this period, your data will be permanently erased or otherwise irreversibly rendered anonymous, unless the law permits or requires that we retain it for longer. The retention period varies depending on the purpose of the processing. For example, after you graduate your data is retained for 10 years so we can refer to it when asked for a reference.

## What your rights are

You have a right to access your personal data, to object to the processing of your personal data, to rectify, erase, restrict and port your personal data.

To request a copy of the personal data we hold for you, or to correct or update this data, please contact the University Data Protection Officer using the contact details above.

If you have queries about any of your other rights regarding our use of your personal data you should contact the University's Data Protection Officer.

#### How to make a complaint

If you are unhappy with the way in which your personal data is being processed you may, in the first instance, lodge a complaint with the University Data Protection Officer using the contact details above.

If you continue to have concerns thereafter you have the right to contact the Information Commissioner for a decision. The Information Commissioner can be contacted as below
